Third meeting of the Global Partnership Steering Committee 25-26 July 2013, Addis Ababa, Ethiopia

Discussion on how evidence expected from the monitoring process can inform the discussion and what other sources of evidence are needed. Individual Steering Committee members are also encouraged to report back on the state of progress on Busan commitments within their constituencies.
