

# Roadmap of the Fourth Monitoring Exercise in Peru 4th Monitoring Round of the Global Partnership 2023 – 2026

#### **BUILDING POLITICAL MOMENTUM**

#### Preliminary phase: (2023)

- 1. In 2023, Peru confirmed its participation in the 4th monitoring round of the Global Partnership for Effective Development Cooperation (GPEDC).
- 2. The Peruvian International Cooperation Agency (APCI, by its Spanish acronym), as the entity in charge of monitoring the effectiveness of cooperation in the country, assumes the role of National Coordinator.
- 3. APCI expresses their decision to kick-start the monitoring exercise in 2024.

### Phase 1: Inception (March – April 2024)

- 1. Define the focal points of:
  - Bilateral and multilateral development partners
  - CSO
- 2. APCI will undertake the South-South Cooperation Self-Assessment
- 3. The reference year for providing data related to monetary figures will be from January to December 2022.
- 4. APCI plans to organize the official launch or multi-stakeholder kick-off meeting in April 2024 by convening a wide range of development actors, within the framework of the Agency's anniversary. It is envisaged to engage the following actors:
  - Members of the International Cooperation National System: public sector within the three government levels, and national and international non-governmental entities registered in APCI's database
  - Bilateral and multilateral development partners
  - Academia: public and private universities
- 5. Based on previous experiences conducting the monitoring exercise, APCI plans to coordinate with focal points from development partners and civil society that are engaged on the effectiveness of development cooperation.

#### **COLLECTING THE EVIDENCE WE NEED**

## Phase 2: Data collection (May – October 2024)

 APCI will lead meetings or workshops of a technical nature with stakeholders from the partner country government, development partners, and CSOs, with the due accompaniment of its focal points, with the aim of explaining the process and the information to be collected.



2. Consultations for data collection will be carried out with stakeholders according to the GPEDC monitoring questionnaire:

- 3. In addition, APCI will conduct and respond to the South-South Cooperation self-assessment.
- 4. The collected data will be sent to the Joint Support Team (JST) of the GPEDC using the Online Reporting Tool (ORT).

# Phase 3: Data review and submission (November 2024 – January 2025)

- 1. APCI, as National Coordinator, will coordinate with the focal points the review and validation of the data collected, in close coordination with the JST.
- 2. Once the JST feedback has been addressed, APCI will formalize the conclusion of this phase by submitting the final data through the ORT.

#### TAKING ACTION AND GENERATING BEHAVIORAL CHANGE

# Phase 4: Dissemination of results and transition to action (February – April 2025)

- 1. APCI will present the results to each stakeholder participating in the monitoring exercise.
- 2. APCI will also explore the possibility of presenting the final results in the framework of APCI's anniversary, given the broad engagement of the various development actors.



# Phase 5: Reflection, dialogue and action (May – July 2025, ongoing until the next monitoring round)

- 1. APCI will convene all development actors participating in the monitoring exercise in order to gather inputs and jointly draw up a roadmap to promote the principles for an effective development cooperation in Peru.
- 2. It is planned to take advantage of the institutionalised spaces and mechanisms that international cooperation has at the country level, as well as others that enable the involvement of various actors, such as:
  - APCI's Anniversary
  - Donors Forum (Foro de Cooperantes)
  - Multisectoral Coordination Committee (CCM, by its Spanish Acronym)
- 3. APCI will use the results of the monitoring round as much as possible to contribute to the implementation of the National Policy on International Technical Cooperation 2030, considering that it is aimed at promoting the effectiveness of cooperation at the country level.
- 4. APCI is particularly interested in reviewing and reflecting on the results of the South-South Cooperation Self-Assessment, which constitute a priority item in Peru's international cooperation.

#### RELEVANT DEVELOPMENT ACTORS FOR THE MONITORING EXERCISE IN PERU

- Government: competent entities in the areas of national development frameworks (CEPLAN), planning (MEF) and gender (MIMP)
- Embassies and cooperation agencies accredited in Peru, as well as international organizations.
   It is planned to coordinate the support of the United Nations Resident Coordinator Office (RCO) in collaboration with UNDP
- CSO: Civil society organizations registered with APCI
